I have the honour to report that, on 03/05/2023 at around 7:40 pm, the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, completely burn down and looted my house located at Motbung Meitei Leikai, Kangpokpi District, P.S. Gamnom Sapormeina.

- vii. Utensils, Stand Fan, Sintex - Rs. 94,000/-
- viii. Solar Set with Battery Inverter - Rs. 50,000/-
- ix. Gas Cylinder with Box (2) - Rs. 12,000/-
- x. Induction, Refregirator - Rs. 25,000/-
- xi. Latrine with BathRoom - Rs. 2,00,000/-
- xii. Sofa Set - Rs. 50,000/-
- xiii. Money - Rs. 50,000/-
- xiv. Books, Clothing - Rs. 11,000/-
- xv. Mobile - Rs. 9,000/-
- xvi. Paddy Bag 20,000/-
- xvii. Voter Card, Gas Book, A/C Pass, JCB Card, Ration card, Pan Card, Isram Card, Certificate (HSLC), Panchayat Member Card, Jamabandi
