I have the honour to report that on 03/05/2023 at around 8:30 pm the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, vandalized my house and looted much of my properties located at Motbung Meitei Leikai, Kangpokpi District, P.S. Gammon Sapormeina.

The properties that were vandalized and looted are as follows:

1. Semi Pucca House Vandalized - Rs. 10,00,000/-
2. Wooden Almirah 4 faces, Iron Godrej, Double Bed, Single Bed - Rs. 82,000/-
3. Fridge, Stand fan, utensils, clothes TV - Rs. 1,45,500/-
4. Gold and Cash - Rs. 1,05,000/-

Total approximate value is about Rs. 13,32,500/- approx.

Regarding the matter I couldn't able to report to the concern Police Station i.e Gammon Sapormeina till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
