Today i.e., 10/03/2024 at about 4.30 pm received an information that on the same day at about 4.25 pm one Alto LX bearing registration No. AS01AM-8580 white in colour which was coming out from entrance gate of one Late. Mv. Asattullah of Lilong Haoreibi Turel Ahanbi Darul Uloom Makha towards the IVR of Lilong Haoreibi Turel Ahanbi dashed to one Bike Fazar bearing registration No. MN02G2973 blue in colour ridden by unknown rider which was coming from IVR of Lilong Haoreibi Turel Ahanbi Dam side towards Lilong Haoreibi Turel Ahanbi Darul Uloom side due to rash and negligent driving on the part of the unknown driver of Alto Car. As a result of which, unknown rider and one pillion rider of the Bike Fazar received injury on their persons and evacuated to hospital for medical treatment and the both vehicles were also partly damaged.
