

I have the honour to report that on 03/05/2023 at around 7:30pm the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, has vandalized and looted my House located at Motbung Meitei Leikai, Kangpokpi District, P.S. Gammon Sapormeina

The properties that were burn down and looted are as follows:

1. Semi Pucca House Burnt - Rs. 15,00,000/-
2. Laisang (Temple) - Rs. 1,00,000/-
3. Furnitures items (Wooden Almirah 4 faces 2 nos) - Rs. 80,000/-
4. Wooden beds 3 nos (2 double and 1 single) - Rs. 75,000/-
5. Electronic Items and Clothing - Rs. 1,30,000/-
6. Jewellery and Godrej - Rs. 50,000/-
7. Utensils and kitchen items - Rs. 70,000/-
8. Lost Documents: Aadhar card, Ration card, Job card, Bank passbook, atm card

Total approximate value is about Rs.20,05,000/-approx.

Regarding the matters I couldn't able to report to the concern Police Station. eGammon Sapormeina till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
