I, the undersigned, have the honour to state the following few facts for your kind consideration and prompt action. That on 28-03-2023 at around 07:00 a.m. one D. Adam Liangmai, Chairman of Konsakhul Village Authority, P.O. Manrtripukhri, P.S. Leimakhong, Kangchup Geljang Sub Division, Kangpokpi District, Manipur along with other hundreds or more accomplishes (villagers of Konsakhul) with deadly weapons such as spears, swords, catapults, sticks, stone etc had come to attacked Leilon Vaiphei Village particularly my residence, i.e, the Chief of Leilon Vaiphei Village Again, on the same day, around 10.a.m many youths of Konsakhul and unknown citizens youths again came to attacked Leilon Vaiphei Village with more numbers and weapons thereby assaulting brutally around 19 innocents' villagers of Leilon Vaiphei Village and dismantling public properties such as Traffic Stands, fencing, Houses etc. and inciting social unrest and causing public panic among the innocent villagers of Leilon Vaiphei and surrounding areas. Moreover, it was well organised crime and the attacked mainly with an intention to kill me, fortunately with timely intervention of my villagers, I survived the incident. I could not lodge the complaint before your goodself in time as I was busy in treatment and taking care of the above brutally assault persons (my villagers) for some time. (Photos of the victims assault persons and damage properties are hereby enclosed)

I, therefore, request you to kindly take up necessary action to punish the above mentioned accused person and his other accomplishes in accordance with law of the land.
