I have the honour to report that, on 03/05/2023 at around 7:40 pm, the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, completely burn down and looted my house located at Motbung Meitei Leikai, Kangpokpi District, P.S. Gamnom Sapormeina.

The properties that were burn down and looted are as follows:

- i. House - Rs. 4,00,000/-
- ii. Cylinder (2 nos) with Box - Rs. 10,000/-
- iii. Bed (2 nos), Phiyankok - Rs. 24,000/-
- iv. Almirah 1, Sintex 1 - Rs. 30,000/-
- v. Gold San 1 - Rs. 14,000/-
- vi. Clothing - Rs. 10,000/-
- vii. Utensils - Rs. 10,000/-
- viii. Mobile Phone - Rs. 8,500/-
- ix. Paddy Bag (30 nos) - Rs. 30,000/-
- x. Cylinder - Rs. 7,000/-
- xi. Cash - Rs. 10,000/-

Total approximate value is about Rs. 5,53,500/- approximately.

Regarding the matter I couldn't able to report to the concern PS i.e Sapormeina PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
