Sir,

I, the undersigned, (Surender Singh 50 yrs) have the honour to report that I and Ashik Ikbal S/O. Nurjum of Alilas Kaspur Dhanghra, Nimtita, Saserganj, Murshidabad, West Bengal were co-worker of one factory of Md. Ramijuddin S/o. Late. Md. Abdul Kadir of Lilong Turel Ahanbi Darul Uloom Wangma.

In the month of Feb. 2022, I returned back home leaving behind my Ecco Van B/Regd. No. HR13N9124 which was bought from the registered owner namely Sanjay Kumar S/o. Nar Singh of 247. A. W. NO. 1 Barahniya Basti line Par Bhaadurgarh, Jhajjar, HR. 124507, Hariyana at the factory giving all the responsibility of my vehicle to Ashik Ekbal. When I returned back at the factory after some days, I came to learn that my Ecco Van had been taken away by Ashik Ekbal and one of his friend Tajbul of Jharkhand without any information to the owner of the factory Ramijuddin Khan and I didn't give information to the owner Md. Ramijuddin Khan that I left the factory for home by leaving Ecco Van to his factory. When I requested Ashik Ekbal to hand over my vehicle, he didn't hand over my Ecco Van and still kept conceal my vehicle in collusion with Tajbul.

I handed over the Ecco Van to Ashik Ekbal in good faith. So, Ashik Ekbal & Tajbul committed the offence of misappropriation of property, criminal breach of trust by concealing the vehicle thereby causing a loss to me.

It is therefore you are requested to kindly take up necessary legal action against Ashik Ekbal and Tajbul and recover my Ecco van at the earliest.
