Subject: - Report.

Sir,

With due respect, I am to report that on today i.e. 27/03/2024 at 05:30 am received a reliable information that some unknown miscreants have stored arms, ammunitions and explosives at Gwarok hill under the jurisdiction of Yairipok Police Station.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with COB Thoubal, 33 AR led by OC/CDO-Thoubal and OC Yairipok PS under the supervision of Addl. SP(Ops)/TBL and under the overall supervision of Sr. SP Thoubal have rushed to the spot immediately and launched massive operation at 6:30 am by using metal detectors. On searching and found undernoted articles i.e. (1) 1(one) No. of 5.56 mm INSAS LMG Rifle bearing registration number 18402593 along with magazine, (2) 01(one) No. of 9 mm SMG Carbine bearing registration number 18250905 along with magazine, (3) 01 (one) No. of Double barrel bearing registration No. 32676-15, (4) 09 (nine) Nos. of 5.56 mm ammunitions, (5) 05(five) Nos. of 36 HE Hand Grenade (can be used as explosive), (6) 2(two) Nos. of 2 inch mortar shells, (7) 01(one) No. of IED, (8) 1(one) No. of Walkie Talkie, (9) 03 (three) Nos. of Tear Smoke Shell Soft Nose, (10) 5 (five) Nos. of Stun Shells, (11) 2(two) Nos. of Cartridge 38 mm Anti-Riot with Rubber Bullet, (12) 05 (five) Nos. Detonators, (13) 10(ten) Nos. of 9 mm ammunitions & (14) 4(four) Nos. of double barrel blank cartridge were recovered from the bushes of Gwarok hill suspected to be hidden by the unknown miscreants. The recovered items have been seized from the spot at 07:30 am by observing formalities. The massive searched operation was conducted from 06:30 am and continue till 08:30 am of the same day.

So, it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
