I have the honour to report that on 03/05/2023 at around 8:30 pm the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, has completely burnt down and looted my House located at Motbung Mamang Leikai, Kangpokpi District, P.S. Gammon Sapormeina.

The properties that were burn down and looted are as follows:

1. Semi-Pucca House burnt - Rs. 15,00,00/-
2. Cow Shed - Rs. 40,000/-
3. Fashino Scooty - Rs. 70,000/-
4. Cattle (cows 8 nos) - Rs. 90,000/-
5. Gold jewellery - Rs. 60,000/-
6. Cash - Rs. 90,000/-
7. Furniture - Rs. 1,50,000/-
8. TV sets - Rs. 20,000/-
9. Laptop - Rs. 40,000/-
10. Utensils and kitchen Items - Rs. 50,000/-
12. Washing Machine - Rs. 15,000/-
13. Cylinder, Gas stove and gas box - Rs. 20,000/-
14. Refrigerator - Rs. 15,000/-
15. Clothing - Rs. 1,30,000/-
16. Generator - Rs. 12,000/-
17. Paddy (Phou) - Rs. 50,000/-
18. Lost Documents : Education Certificate, Land patta, Aadhar Card, pam card, Voter Card, Atm card, Bank Passbook, CMHT card

Total approximate value is about Rs. 25,02,000/- approx.

Regarding the matters I couldn't able to report to the concern Police Station. eGamnom Sapormeina till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.


