Subject: First Information Report (FIR) regarding illegal shooting and killing of Mithun belonging to the members of Leilon Area Siel (Mithun) Society (LASS) by the villagers of Konsakhul during 144 CrPC of 1973 imposed by the DC, Kangpokpi.

Respected Sir,

This is to inform you and request your prompt action on the subject mention above.

That, the ongoing inter-village tension between Leilon Vaiphei village and Konsakhul village erupted due to the destroying mithum fencing by villagers of Konsakhul on 08-03-2023 and 25-03-2023 going against the agreement sign by five villages on 24-03-2001. The fences constructed by Leilon Area Siel (Mithun) Society (LASS) covering the designated area for rearing of Mithuns was destroyed heinously by villagers of Konsakhul. Two FIRS were lodged by Leilon Area Siel (Mithun) Society to the Officer incharge, Leimakhong Police Station on 11-03-2023 and 26-03-2023 (documents enclosed). But no action has been taken to the perpetrators till date.

That, due to the prevailing law and order situation 144 CrPC of 1973 (curfew) was imposed in the whole area of Konsakhul and Leilon Vaiphei Village area by the District Magistrate Kangpokpi on 28-03-2023 which is still in effect till this day (document enclosed). Despite the imposition of the probatory order some villagers of Konsakhul freely moved with arms and shot and killed a mother Mithun belonging to the members of Leilon Area Siel (Mithun) Society recently giving birth to a calf.

The calf also died later (pictures and videos enclosed for evidence).

Siel(Mithun) has a traditional significance socially, religiously and economically. The illegal killing of the reared mithuns like this direct attack and challege to the owners and the society and the whole community. Despite the imposition of curfew, the continuous crime committed by villagers of Konsakhul shows utter failure of law-and-order situation in the area. If the culprits are not booked at the earliest there is danger of outbreak another inter-village feud which will disturb peace and law and order situation in the area.

It is, therefore, our earnest request to your good office, to book the culprits and take prompt action on time to prevent untoward incidents in the near future.
