



I have the honour to report that, on 03/05/2023 at around 7:40 pm, the large number of Kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, completely vandalized and looted my house located at Motbung Meitei Leikai Kangpokpi District P.S. Gamnom Sapormeina.

The properties that were vandalized and looted are as follows:

- iv. T.V sets - Rs. 27,000/-
- v. Laptop - Rs. 40,000/-
- vi. Electronics Item - Rs. 45,000/-
- vii. Gas Cylinder, Gas stoves, Gas Box - Rs. 32,000/-
- viii. Gold jewelry - Rs. 47,000/-
- ix. Cash - Rs. 65,000/-
- x. Clothing - Rs. 12,000/-
- xi. Grocery Shop - Rs. 2,00,000/-
- xii. Poultry - Rs. 1,00,000/-
- xiii. Water Pump & Sintex - Rs. 17,000/-
- xiv. Godrej - Rs. 27,000/-
- xv. Certificates, Aadhar, ATM Passbook CMHT, Voter Id, Job Card, Birth Certificate
- xvi. Rice Paddy - Rs. 30,000/-

Total approximate value is about Rs. 13,82,000/- approximately.


