With due respect, I have the honour to state that on the 2nd June 2023 at around 4:50 PM unknown miscreants numbering more than 200 people from the Meitei community suspected to be members of Arambai Tenngol, Meitei Leepun, Extremist volunteer holding deadly weapon including Automatic Rifles attack our village i.e. Bethel Village Kangchup Geljang Sub-Division, Kangpokpi Discrict. They robbed, demolished and burnt down my house along with the following properties and important documents etc. The details are as under:
