They robbed, demolished and burnt down my house along with the following properties and important

documents etc. The details are as under: Remarks Worth Destroyed property SI. No. Partly damaged 3,00,000/-Pucca Building 1 Destroyed& robbed 3.00,000/-**Furniture** 2 Destroyed & robbed 2,00,000/-Household items 3 8,00,000/-Total

The Total amount of destroyed properties are estimated at Rs. 8,00,000/- (Rupees eight lakh) only. The incidents could not be reported immediately due to insecurity of our lives and volatile situation of the area.
