With due respect, I have the honour to state that on the 2<sup>nd</sup> June 2023 at around 4:50 PM unknown miscreants numbering more than 200 people from the Meitei community suspected to be members of Arambai Tenngol, Meitei Leepun, Extremist volunteer holding deadly weapon including Automatic Rifles attack our village i.e. Bethel Village Kangchup Geljang Sub-Division, Kangpokpi District. They robbed, demolished and burnt down my house along with the following properties and important documents etc. The details are as under:

The Total amount of destroyed properties are estimated at **Rs. 8,00,000/-** (Rupees eight lakh) only. The incidents could not be reported immediately due to insecurity of our lives and volatile situation of the area.
