They robbed, demolished and burnt down my house along with the following properties and important documents etc. The details are as

under: Remarks Worth Destroyed property Completely destroyed SI. No. 8,00,000/-Tin roof Kaccha Building 1 Completely destroyed 5,00,000/-Toilet complex 2 Completely burnt 3,00,000/-**Furniture** 3 Destroyed & robbed 4,00,000/-Household items 4 Completely burnt 1,00,000/-Fire wood & store house 5 21,00,000/-Total

The Total amount of destroyed properties are estimated at **Rs. 21,00,000**/- (*Rupees twenty one lakh*) only. The incidents could not be reported immediately due to insecurity of our lives and volatile situation of the area.
