Sir,

I the undersigned, Caretaker Chairperson of Lilong (Thoubal) Municipal Council beg to lodge this report as follows.

That on spot verification of the Shops/Vendors within the jurisdiction of the Lilong (Thoubal) Municipal Council, it has been found that the Registration Certificate and Shops/Vendors Licence have been issued in favour of one Smt. Wajida Khattun, W/o Md. Idris Ali, Proprietor of M/s Napisha Pharmacy, resident of Lilong Chaobok Mairenkun, P.O. & P.S. Lilong, District Thoubal, Manipur permitting to run her business dealt in Pharmaceutical items in the premises described therein under Registration No.74/R-S/LMO dated 30.08.2023, which shall remain in force till the 31st August 2024. The said certificate/license was issued on 30.08.2023. In the said two documents (Registration Certificate and Shops/Vendors Licence), a forging signature in the name of Ibemcha, Chairperson Lilong Municipal Council with the seal of Chairperson Lilong (TbL) Municipal Council was found. It is worth to mention herein that in the Lilong (Thoubal) Municipal Council there is no Councillor/Chairperson named Ibemcha except the present complainant. On seeing the said signature, it seems that someone has tried to tarnish the image of the undersigned before the public by forging her signature and fabrication of documents. On further perusal of the said two documents, it has also been found the signature of one Rajen Singh with the seal of Executive Officer, Lilong Thoubal Municipal Council. In this regard, it is to state that one M. Rajen Singh was the Executive Officer, Lilong (Thoubal) Municipal Council till 29.02.2024. However, so far to my knowledge, the said signature of Rajen Singh appears in the two documents are not similar with the said M. Rajen Singh and as such, it appears to be also forging one.

It is also pertinent to mention herein that at the time of issuing the said License/Certificate i.e. on 30.08.2023, the undersigned was not the Chairperson of the Lilong (Thoubal) Municipal Council. In fact, the undersigned was appointed as Caretaker Chairperson of Lilong (Thoubal) Municipal Council vide Order No.ELECT-201/1/2020-MAHUD-MAHUD- Part(2) dated 07.12.2023 issued by the Joint Secretary (MAHUD), Government of Manipur.

Taking into the above aspects, it reveals that Registration Certificate and Shop/Vendor Licence were issued by someone by fabricating the signatures of the undersigned and the then Executive Officer of the Lilong (Thoubal) Municipal Council, which is highly serious nature of criminal activities not permitted by the prevailing laws of the Country. It is further to state that the accused persons have forged the signatures of Chairperson and Executive Officer of a Municipal Council for a genuine purpose. The accused have forged the records to be maintained by a public servant/office. Apart from it, such forgery was also for the purpose of harming the reputation of a person who has holding a public office. Therefore, an appropriate legal action is highly required to be initiated against the accused persons.

It is therefore, requested to kindly investigate in the matter and register a criminal case as per law against the persons who has committed the forgery of signatures and fabrication of the documents of a public office. Enclosed:-
