Sir, With due respect, I am to state that on 3rd May 2023 at around 8:00 pm, our locality, Mothung

Meitei leikai was under mob attacked by thousands of Kuki community miscreants. As a result, many houses and properties were destroyed and burnt to ashes including my house (Permanent residence).

Immovable properties like houses (approx. 8 lakhs) including movable properties -(a). Furniture: 3 almirah worth around 1 lakh, 2 godrej worth around 50 thousand, 3 beds worth arounds 1.5 thousand 4 bench worth around 20 thousand, 6 tables worth around 40 thousands, 5

(b). Electronic items: TV worth 15 thousand, Washing machine worth 10 thousand, refrigerator

worth 15 thousand, 3 rice cookers worth 20 thousand, 1 laptop worth 50 thousand. ©. Kitchen items: 3 cylinders worth 10 thousand, 2 gas stove worth 8 thousand, utensils worth

around 50 thousand, 1 kitchen almirah worth 20 thousand.

(d). Cash for marup worth Rs. 5 lakhs. (e). Household stuff including clothing and daily needs worth Rs. 1.5 lakhs.

(f). 3 Hens, 7 ducks and 3 cats worth Rs. 15 thousand.

Total loss of properties at my residence would be above 25 lakhs (approximately).

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodge my complaint at Lamphel Police Station as we had fled from my residence to save ourselves from the rioters.

We are currently unemployed and taking shelters at our relative's place.
