Ningthoujam Toma of Leimakhnog Bazar and looted much of my properties located at Leimakhong Bazar.

The Properties that were burn down and looted are as follows:

- 1. Celling fan = Rs. 1600/-
- 3. Table fan = Rs. 1000/-
- 4. Refrigerator Rs 25000/-
- 5. Rage & Counter Rs. 63000/-
- 6. B.P. machine & dressing equipment = Rs. 10000/-
- 7. Medicines = Rs. 900000/-

Total approximate value is about Rs. 1000600/- Approximately.
