

I have the honour to report that on 29/05/2023 at around 1:30 pm, the large number of kukis militant with sophisticated armed, knives, iron rod, and weapon sharp object have come and burn down valuable items as well as looted much of my properties located at Leimakhong Bazar.

The Properties that were burn down and looted are as follows:

1. 1 (one) Iron Grodress – Rs. 30000/-
3. 2 (Two) wooden Almira – Rs. 50000/-
4. TV set – Rs. 30000/-
5. Refrigerator – Rs 25000/-
6. Washing machine – Rs. 35000/-
7. 2 double beds – Rs 50000/-
8. 3 Cylinder & 1 gas stove – Rs. 15000/-
9. 2 Laptop – Rs 120000/-
10. Giger – Rs. 100000/-
11. Clothing – Rs. 270000/-
12. Utensil – Rs. 50000/-
13. 2 Matress – Rs. 45000/-
14. 3 Santex – Rs. 21000/-

Total approximate value is about Rs. 8,41,000/- Approximately.

Regarding the matters I couldn't able to report to the concern Police Station i.e. Gamnon Sapormeina PS till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.
