

Sir,

I have the honour to report that on 29/05/2023 at around 1:30 pm, the large number of kukis militant with sophisticated armed, knives, iron rod, and weapon sharp object have come and burn down valuable items as well as looted my shops (Boyz Mobile Home Appliances) owned by Prakash Gupta and looted much of my properties located at Leimakhong Bazar.

The Properties that were burn down and looted are as follows:

1. Refrigerator – 25x15000= Rs 825000/-
3. Washing machine – 70x18000= Rs. 1260000/-
4. TV Samsung 32 inch – 15x 15000= Rs. 225000/-
5. TV Samsung 32 inch smart – 20x 20000= Rs. 400000/-
6. TV 50 inch – 10x 50000/- = Rs. 500000/-
6. TV 55 inch – 10x 60000/- = Rs. 600000/-
7. Mebiatek TV 32 inch – 10x 10000/- = Rs. 100000/-
8. Mebiatek TV 40 inch – 10x 20000/- = Rs. 200000/-
9. Mebiatek TV 43 inch – 15x 25000/- = Rs. 375000/-

Total approximate value is about Rs. 4485000/- Approximately.

Regarding the matters I couldn't able to report to the concern Police Station i.e. Gamnon Sapormeina PS till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
