Subject: - Complaint letter regarding threat from unknown persons.

Respected Sir,

I Gaikhamdim Marangmei (s/o late Kamudun Marangmei), resident of Lilong Chingkhram village, Lilong Thoubal, Manipur, I am writing this letter to bring to your notice a serious issue that I faced while travelling along the National Highway in the month first week of March 2024, also on January 26 and February 9, 2024. I request you to take immediate action against the culprits and ensure my safety and security.


On the March 10, when I was driving from Imphal to Lilong (Chingkhram village) around 11 pm a group of four to five men in mask on a gypsy vehicle without number plate stop my vehicle between Lilong bazaar and Ushoipokpi. I asked them who they are and why they were stopping me, but they did not answer. They threatened me with dire consequences if I did not cooperate. Later, after checking the car for about 5 minutes and they fled away with the warning that whenever they signal to stop I should stop the car. Almost the same thing have also happen on January 26, 2024 further on February 9, around 10 am, somewhere around the border of Senapati and Kangpokpi district, when I was traveling from Kohima to Lilong. I am working with Ministry of Home Affairs, Government of India MHA and presently posted in Kohima and frequently used this routes

In this regard, I request you to kindly register my complaint and investigate the matter urgently. I do not know who these people are and what they want from me. Earlier, some years back there has been an extortion call from unknown number also there has been an incident were our fish pond in Chingkhram Lilong was poisoned by some unknown miscreant for which I have also filed an FIR in that regard in your station. Further, it is to mention that officially, I am posted in Kohima, but due to the nature of my work I had to frequently travel to different place in different districts of Manipur as well other part of India. I have also enclosed a copy of my employee certificate and Aadhaar card for ready reference.
