On the 2nd June, 2023 at around 5PM, unknown miscreants belonging to Meitei community, numbering more than 500 people suspected to be members of Arambai Tengol, Meetei Leepun and others have attack our village i.e. Bethel Village under Kangchup Geljang Sub-Division by holding deadly weapons including automatic rifles and bomb. The miscreants have ransacked and burnt down my RCC House and all properties like furniture, kitchen items, clothing, important documents, Electric Rice Mills, Grains and Rice, Poultry and domesticated animals and other properties inside the house. The estimated value of properties lost, ransacked and burnt down by the miscreants is estimated to be Rs. 90,00,000/- (Ninety lakhs only).

I, therefore request you to kindly take necessary action in this regard for which I shall remain thankful to you.
