



I the undersigned namely Shri Ngampu Lhouvum a permanent resident of Kangchup Twikun Villlage, Kangchup Geljang Sub-division, Kangpokpi District, which fall under the Jurisdiction of your station that:-

1. I am the Proprietor of Integrated Poultry Farm, Licence No. SH-ADC 3514B registered under District Council Administration, Sadar Hills Autonomous District Council & UDYAM Registration No. UDYAM-MN-11-0000329 registered under Ministry of Micro, Small and Medium Enterprises, Government of India. The said farm was operated at Kangchup Tuikun/Twikun Village.
2. That on date 28th May 2023 around 11:30 am, a thousand of Meitei Mob/Arambai Teggol/Meitei Leepun/Manipur Police Commando assisted by Villagers of Kadangband Villagers, Imphal West attacking our Village (i.e., Kangchup Twikun, Kangpokpi District) and vandalized and burnt down some of the Houses at our village including the above mentioned integrated Poultry Farm.
3. That the above mentioned integrated Poultry Farm (i.e., my Farm) is semi Pucca House (100 x 30 ft) in size well electric fitted, 10 bags of Poultry Feeds including Poultry Feeders, utensils and Water droppers others equipment etc. The burnt down properties is worth around 5.5 Lakhs in Rupees.
4. Due to Therefore, I earnestly request your good office to kindly take necessary actions as per the law of the land.
