



With due respect, I have the honour to report that, on 3/5/2023 at around 5:00 pm, large numbers of kuki militants with sophisticated weapons came to our village and broke into my house and completely burn down as well as destroyed my house and also looted many valuable properties by the militants located at Motbung Bazar, Kangpokpi Dist. P.S- Gamnom Sapormeina.

The properties that were burn down and looted are as follows:

1. House (kutchu) Rs. 5,00,000/-
2. Electronic Items-Rs 40, 000/-
3. Furniture items- Rs. 95,500/-
4. Kitchen Items-Rs. 40,000/-
5. Clothing- Rs. 60,000/-
6. Paddy 10 bags- Rs. 10,000/-
7. Domestic Animal ( Duck 20 pcs)- Rs 15, 000/-
8. Sentex- Rs. 2500/-
9. 1 bicycle & 1 Aactiva 6G-Rs 1,27,000/-

Total approximate value is about Rs, 8,90,000/- approximately.

Regarding the matters I couldn't able to report to the concerned PS i.e. Gamnom Sapormeina PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly take up necessary legal action.


