



I have the honour to report that on 05/05/2023 at around 6:30 pm, large number of kuki militants with sophisticated weapon have come and looted many valuable items as well as completely burn down my house located at Motbung bazar, Meitei Leikai.

The properties that were burn down/looted are as follows:

1. House (Kutcha House) - Rs. 5,00,000/-
2. Furniture - Rs. 50,000/-
3. Kitchen items - Rs. 1,00,000/-
4. Cash - Rs. 20,000/-

Total approximate value is about Rs. 6,70,000/-.

Regarding the matters I couldn't able to report to the concern PS i.e. Gamnom Sapormeina PS till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is, therefore, requested you to kindly take up necessary legal action.


