Subject: Report.

Sir.

I have the honour to state that today i.e on 11/01/2023 at about 11:30 am, selected combined teams of Kangpokpi District Police (i.e GSPM-PS, OC/KPI-PS & LMK-PS) led by DSP/GSPM have conducted random frisking and checking at the road leading to Leimakhong-PS junction under the overall supervision of SP/Kangpokpi. The combined teams stopped one Eco Sport car bearing Regn. No. TR 01BD-0259 (Silver colour). On verification of the driver, identified himself as Ngamboi Haokip (30) S.O Jangmang Haokip of N. Molsophai village, PO & PS: Cepur, Churachandpur District, Manipur and the occupant as Thangminlen Kipgen (32) S/O Satlun Kipgen of Pangjang village, PO & PS: Saikul, Kangpokpi District. Manipur. During preliminary questioning of the driver and occupant, they were nervous and gave contradict statements by denying to possess contraband drugs in the vehicle. On being found behaving in suspicious manner, the two individuals were separately enquired in tactful manner and finally admitted themselves as a drug peddler who are in possession of Heroin No. 4 concealed in the vehicle.

On confirming the presence of contraband drugs in the vehicle, no further checking was done in order to observe formalities at the spot. So, immediately Executive Magistrate was inform to be present in conducting checking of the vehicle and accordingly Executive Magistrate (SDO/SDM)-Kangchup Geljang, Kangpokpi was present at the spot. In the presence of the said Lecutive Magistrate and two civil independent witnesses, the two detained individuals have taken out the concealed drugs (i.e. Soap cases containing suspected to be contraband drugs Heroin No. 4) which were neatly stacked in a modified compartment beneath the rear bumper of the vehicle. On counting the recovered soap cases one by one, found 100 (one hundred) numbers in total. Out of the total 100 soap cases, 50 (fifty) soap cases were put together in one black polythene bag and marked as Lot-1 for identification. Similarly, the remaining 50 (fifty) soap cases were again put together in another black polythene bag and marked as Lot-2. The two Lots i.e Lot-1 & Lot-2 were weighed by using weighing machine in the presence of executive magistrate. independent witnesses, detained persons and found 2.050 kgs and 2.030 kgs respectively including the weight of the plastic soap cases and black polythene bags. And the combined weight of Lot-1 & Lot-2 was weighed and found weighing 4.080 kgs including the weight of plastic soap cases and polythene bags.

The recovered 4.080 kgs of suspected to be contraband drugs Heroin No.4 and other items were seized in presence of Executive Magistrate, Independent witnesses and detained persons at 2:16 pm by preparing a formal seizure memo and also obtained their signatures. The detained persons were formally arrested at 2:25 pm by observing formalities.

Following the order passed by the Hon'ble Spl Judge ND & PS Manipur vide No. SPL-C/ND & PS/2019/659-663 dated 26.11/2019 corresponding Cril. Appeal No.652 of 2012 (MANU/SC/0073/2016:2016) 3 SC & 379) the necessary proceedings laid under ND & PS Act will be observed before the Hon'ble Court of JMFC, Kangpokpi.

Therefore, the two arrested accused persons and seized items are handed over to you for taking further necessary legal please.
