Today i.e. 15/01/2024 at 6:35 pm received a reliable information that on the same day at around 6:30 pm, one Tata Truck (long heavy vehicle carrier) bearing regd. No. MN05C-3841 driven by one unknown driver which was proceeding from Bishnupur side towards Imphal side collided with one Maruti SX4 bearing regd. No. MN01W1694 driven by one unknown driver which was proceeding from the opposite direction at Maibam Chingmang along Tiddim road while the long heavy vehicle carrier Tata Truck was overtaking one light vehicle due to rash and negligent driving on the part of unknown drivers of both vehicles.
