



Sir,

With due respect, I have the honour to state that, on the 5<sup>th</sup> June, 2023 at around 3:00 pm, miscreants numbering more than 500 people from Meitei community suspected to be members of Arambai Tengol, Meetei Leepun and other Extremist volunteers by holding deadly weapons like Automatic Rifles attacked our village i.e K. Songlung Village under Kangchup Geljang Sub Division, Kangpokpi District.

In the incident, the miscreants have burnt down my house along with all my household properties worth Rs. 90,00,000/- (Ninety Lakhs only) into ashes.

The incident could not be reported immediately due to insecurity of our lives and volatile situation in the area.

I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime.


