



Subject – Request to register FIR.

Sir,

This is to inform you that on the 4th of May 2023, Meitei mobs consisting of members of neighbouring Meitei villages, members of the Arambai Tenggol wearing their trademark black T-shirts, escorted by members of the state police commandos attacked and burned down the Kuki villages of Bethel and Nakhojang, which are villages neighbouring our village. They were armed with sophisticated automatic weapons and shot indiscriminately with an intent to kill.

Thus, out of fear of death, we were forced to flee our village, as we would be next in line.

The total estimated worth of our properties and possessions left behind i.e., livestock including cows, pigs, house, rice mill, four-wheeler (MN01AW1071), two-wheeler (pulsar) and paddy field is Rs. 65,50,000/- (sixty-five lakhs fifty thousand only).

I therefore humbly request your good office to kindly take necessary action in this regard.


