Sir,



I have the honour to report that today i.e., 24/02/2024 at @ 2:10 pm, an unruly mob numbering about 70/80 suddenly gathered holding firearms and other deadly weapons stormed into the 2<sup>nd</sup> gate i.e. western side of Leishangthem Police Out Post, Thoubal District with an intention to snatch arms and ammunitions. In which around 40 unknown armed personnel forcibly entered the office rooms & Arms Kote. The police team directed to disperse it by way using minimum forces. The unruly mob entered and created a havoc inside our police out post. In that incident, four locks of different rooms including that of Arms Kote and around 10 numbers of trunk boxes kept inside the Out Post belonging to different Police personnel were found damaged. The mob was later dispersed at around 2:25 pm.

It is, therefore, requested kindly take up necessary legal action.
