



Subject: Report on crimes of unlawful displacement, looting, vandalism, and discrimination of
Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows:

I am a scheduled tribe belonging to the *Zou Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of Sugnu Lamhang Village, P.O. & P.S.- Sugnu, district- Chandel, Manipur.

That, due to the ethnic crisis that erupted in the State of Manipur, we deserted our rented house owned by namely, **Dr. Haopu (7005838520)**, and on the 5th of May, 2023 at around 4:30 PM during our absence, a mob of armed Meitei/ Meitei suspected to be members of Arambai Tengool, Meitei Leepun along with the locals in and around the area **attacked our locality**, in the process they have looted and vandalised all my household items/ movable assets from my rented house which is located at *House No. 34, 1st Street, New Checkon, Tribal Market, New Lambulane, P.O./ P.S.- Porompat and district-Imphal East, Manipur.*

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.8,00,000 (*Rupees Eight Lakhs*) Only, inclusive of the household items/ movable assets.

That, I am filing this report lately as I was with my family in the State of Mizoram, far away from the violence in a remote area for months, working as a daily wager.

Therefore, I humbly pray you to kindly register a ZERO FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
