That, due to the ethnic crisis that erupted in the State of Manipur, we deserted our above mentioned permanent resident on the 13th May, 2023 at around 6:30 AM, to save ourselves from the majority Meetei/ Meitei warmongers, where, we fled to Mizoram state by air-transport/ aircraft.

That, it came to my knowledge from a reliable source, that a mob of Meetei/Meiteis suspected to be members of Arambai Tenggol, Meira Paibis and the locals in and around the area have looted and vandalised all my household items/ movable assets on the 22nd of Feb., 2024 at around 8:30 PM located at the above mentioned address.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs.25,00,000/- (Rupees Twenty-Five Lakhs) Only inclusive of the my household items/ movable alone.

That, it brings to my attention & concern that there might be an illegal activities being conducted at the above mentioned residence/premises.

Therefore, I humbly pray you to kindly register a ZERO FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application today.
