



Subject: Report on crimes of unlawful displacement, looting & vandalism and discrimination of Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the *Hmar Tribe*, which is a recognized tribe under the Constitution of India and a permanent resident of *House No. 19, 1st Street, New Lambulane, P.O. & P.S.- Porompat & district- Imphal East, Manipur bearing Patta No. 1187 / 2020 / 829, covering CS Dag No.2157/ 2158.*

That, due to the ethnic crisis that erupted in the State of Manipur, we deserted our above mentioned permanent resident on the *13th May, 2023* at around *6:30 AM*, to save ourselves from the majority Meetei/ Meitei warmongers, where, we fled to Mizoram state by air-transport/ aircraft.

That, it came to my knowledge from a reliable source, that a mob of Meetei/Meiteis suspected to be members of Arambai Tengol, Meira Paibis and the locals in and around the area have looted and vandalised all my household items/ movable assets on the *22nd of Feb., 2024* at around *8:30 PM* located at the above mentioned address.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about *Rs.25,00,000/- (Rupees Twenty-Five Lakhs)* Only inclusive of the my household items/ movable alone.

That, it brings to my attention & concern that there might be an illegal activities being conducted at the above mentioned residence/ premises.

Therefore, I humbly pray you to kindly register a ZERO FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application today.
