



Subject: Report

Sir,

I have the honour to report that today i.e., 3rd April, 2024 at about 6:10 p.m., received a reliable information corroborated with the intelligence of 4 AR Int. team about presence of some anti-social elements in and around Kongpal Khongkham Leikai, Imphal East District. Based on the said information, teams of CDO Unit Imphal East led by myself under the command of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE and Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the overall supervision of Shri. K. Meghachandra Singh, MPS SP/IE District conducted a random mobile frisking and checking to the suspected passersby.

In that, one suspected person was detained for spot checking and verification at Kongpal Khongkham Leikai near AAA field, Imphal East District. On checking his body, there found one mobile phone from his possession. On verification, the detainee identified himself as one; **Naorem Bode Singh (47 years) S/o N. Dolen Singh of Singjamei Makha Naorem Leikai, Singjamei Police Station, Imphal West District** an active member of the outfit KCP (Noyon). On further verification, the detainee stated that he joined the said organisation in the month of October, 2023 through one S/S - Assistant Finance Secy. Mr. **Bungcha Singh @ Winner @ Meiraba** of KCP (Noyon) and presently working under his command. Further, the detainee stated that he is directly involved in the extortion of money from the general public for raising their party fund on the advice and command of the said Mr. **Bungcha @ Winner @ Meiraba** of KCP (Noyon). He further stated that, recently on the advice of the said Mr. **Bungcha** of KCP (Noyon) he had extorted money from the pharmacy shops located at Kakwa Bazar, Imphal West District.

So the detainee, **Naorem Bode Singh (47 years) S/o N. Dolen Singh of Singjamei Makha Naorem Leikai, Singjamei Police Station, Imphal West District** was arrested from the spot i.e. Kongpal Khongkham Leikai near AAA field, Imphal East District at 6:45 p.m. and seized one mobile phone (LAVA LF1001) bearing IMEI no. 354609484792916 & 354609484792924 along with two Airtel SIM cards bearing no. 8991160990015801694U & 8991160990020086982U from his possession by observing due formalities at 6:55 p.m.

Therefore, the arrested person along with seized mobile phone is being handed over to you for taking up further necessary legal action against him.
