





Today, i.e, 03/04/2024 at 8:30 pm, received an information that on that same day about 8:00 pm, some unknown persons were reportedly stealing some house whole items from the abandoned houses located in and around New Lambulane 2<sup>nd</sup> Street, Imphal East District, Manipur. Accordingly, a team of Porompat-PS rush to the said area to effect arrest the unknown persons. On reaching at Hatta near Traffic Point found that, two unknown persons were coming toward Hatta Golapati from New Lambulane 2<sup>nd</sup> Street on a Diesel Auto Rickshaw bearing registration MN01F 5627 in a very suspicious manner along with some suspected stolen items. Immediately, the Police team stopped the Re- Auto Rickshaw at Hatta near Traffic point for verification. On spot verification, the two unknown persons were identified as (1) Thingbaijam Manglemba Singh (49) S/o Late Th. Mohindro Singh of Phoubakchao Ikhai, Bishnupur A/P New Lambulane and (2) Wahengbam Jogendro Meitei (46) S/o W. Joy Meitei of Wangoi Top Siphai, Imphal West. On further verification, they stated that the said house whole items were stolen from unknown abandoned houses of New Lambulane 2<sup>nd</sup> Street areas. So, they were arrested and seized the Diesel Auto rickshaw along with some stolen items and brought at PS for further necessary action.

Hence, a suo-motto case under FIR No. 231(4)2024 PRT-PS u/s 447/448/451/380/34 IPC has been registered for investigation.
