Subject – Request to register FIR.

Sir,

This is to inform you that on the 4th of May 2023 around 10 AM, a Meitei mob numbering over 200 people consisting of members of the neighbouring Meltei village called Chirang, arrived at my village armed with sticks and threatened violence unless we abandoned our village.

Thereafter, on the 8th of May 2023, around 2 PM, a Meitei mob numbering over 300 people attacked my village. The mob consisted of the aforementioned members of the neighbouring Meitei village of Chirang, members of the Arambai Tenggol wearing their trademark black T-shirts, as well as members of the state police commandos. They were armed with sophisticated automatic weapons and shot indiscriminately with an intent to kill. The police commandos shot blank fire to intimidate and scatter the village members. We were thus forced to flee our village for fear of death.

The total estimated worth of our properties and possessions left behind i.e., livestock, house is Rs. 10.00,000/- (Ten lakhs only).

I therefore humbly request your good office to kindly take necessary action in this regard.
