Sir,

With respect, I have the honour to state the following few lines for your kind consideration and necessary action.

That, my sister in law namely Achoibam Bembem Devi, 39 yrs. W/o. A. Thabal Singh of Khuga Meitei Christian Leikai, CCP-Dist. at present she was staying at Kwakta Sericulture Relief Camp.

That on 21/03/2024 @ 2:09 am, one Arambam Sanjit Singh, 47 yrs. S/o. A. Damu Singh of Nambol Ward No.10 along with one Auto Driver namely Langpoklakpam Raju Singh S/o. L. Kaoba Singh of Nambol Maibam Chingning had come with one Diesel Auto bearing Reg. No. MN05B-8172 which was hired by himself and called out Achoibam Bembem Devi and abducted her. When they reached Thamnepokpi area, due to the aggressive nature of the individual names mentioned above, the lady jumped out of the Auto Rickshaw and sustained injuries on her person and evacuated to District Hospital, Bishnupur and later on referred to Raj Medicity, North AOC, Imphal.

That, on 22/03/2024 at @ 6:30 am, received information that Achoibam Bembem Devi, 39 yrs. who was referred at Raj Medicity, Imphal has been succumbed to her injury by our family members.

On receiving the said information family members rushed at Raj Medicity, Hospital and on reaching there, the family members found her unconscious, later the Raj Medicity Hospital Authority reported that she have been succumbed due to her injuries.

Therefore, it is requested to kindly take up necessary legal action as per admissible law against the accused persons.
