They were armed with sophisticated automatic weapons and shot indiscriminately with an intent to kill.

Thus, out of fear of death, we were forced to flee our village, as we would be next in line.

The total estimated worth of our properties and possessions left behind i.e., livestock, house, and Paddy fieldis Rs. 22,00,000/- (twenty-two lakhsonly).

I therefore humbly request your good office to kindly take necessary action in this regard.
