Today i.e. 6/3/2024 at 10:31 am, received an information that on the same day at about 10:25 am, one motorcycle Royal Enfield Himalayan bearing regd. no. MN01AL1312 which was proceeding from Wangjing towards Thoubal side along NH102 and ridden by unknown person met an accident with one scooter Honda Activa bearing regd. no. MN01AB9366 ridden by unknown person at Khangabok Bazar while the Honda Activa was crossing the highway due to rash or negligent riding on the part of both riders. As a result of it, unknown rider of the Honda Activa sustained severe injuries and both vehicles were also partly damaged. The injured person was evacuated to the District Hospital Thoubal for medical treatment.
