They were armed with sophisticated automatic weapons and shot indiscriminately with an intent to kill.

Thus, out of fear of death, we were forced to flee our village, as we would be next in line.

The total estimated worth of our properties and possessions left behind i.e., livestock including cows, paddy field, house is Rs 21,50,000/- (twenty-one lakhs fifty thousand only).

I therefore humbly request your good office to kindly take necessary action in this regard.
