Sir,

This is to inform you that on the 5th of May 2023, around 3 PM, a Meitei mob numbering over seven hundred (700) attacked my village. The mob consisted of members of neighbouring Meitei villages on the frontline, who were backed up by members of the Arambai Tenggol wearing their trademark black T-shirts, along with state police commandos bringing up the rear. They were armed with sophisticated automatic weapons and shot indiscriminately with an intent to kill.

We were forced to flee our village. My 5-room house was burnt down and all possessions such as furniture and household items were destroyed.

I therefore humbly request your good office to kindly take necessary action in this regard.


