

Subject – Request for registering FIR.

Sir,

This is to inform you that on the 28th of May 2023, around 11 AM, a Meitei mob numbering over 500 people, consisting of members of the Arambai Tenggol wearing their trademark black T-shirts, along with state police commandos attacked my village. They were armed with sophisticated automatic rifles and shot indiscriminately with an intent to kill.

We were forced to flee our village. I incurred the following losses –

- Semi-puuca 6-room house burnt down.
- Poultry farm with 1000 chicks and feed worth Rs. 4,50,000/- (four lakhs fifty thousand only) destroyed.
- Pharmacy worth Rs. 6,00,000/- (six lakhs only) looted and destroyed.
- Bajaj Pulsar bike with all documents stolen.
- 80 bags of paddy.
- Wood planks worth Rs. 3,00,000/- (three lakhs only).
- Iron rods worth Rs. 3,50,000/- (three lakhs fifty thousand only).
- Furniture & electronics.

I therefore humbly request your good office to kindly take necessary action in this regard.


