Subject - Request for registering FIR.

This is to inform you that on the 28th of May 2023, around 11 AM, a Meitei mob numbering Sir, over 500 people, consisting of members of the ArambaiTenggol wearing their trademark black Tshirts, along with state police commandos attacked my village. They were armed with sophisticated automatic rifles and shot indiscriminately with an intent to kill.

We were forced to flee our village. I incurred the following losses –

- 11-room kutcha building house burnt down.
- 100 bags of paddy looted.
- Tiller machine (kabuta).
- Washing machine and TV.
- 9 wooden almirahs& 11 beds.
- 3 LPG cylinders.
- 1 solar panel and battery.
- Cash worth Rs. 3,00,000/- (3 lakhs only).

I therefore humbly request your good office to kindly take necessary action in this regard.
