As per source report, from around 10.30 am of 3rd May, 2023, there has been report of vandalism, arson, and looting of properties at Thengra Leikal and Khumajamba of Churachandpur district, Torbung Bangla, Phougakchou Ikhal of Bishnupur district, Haokip Veng, New Checkon of Imphal East, Palte Veng, Khongsal Veng of Imphal West, Motbung Meitel Leikal, Ekou Bazaar of Kangpokpi, Moreh Bazaar, Premnagar of Tengnoupal district and other places of Manipur. There have been incidents of killing at Tronglaobi of Bishnupur district, Khongsal Veng, Phayeng of Imphal West district, Sugnu of Kakching district, Sagolmang of Imphal East district and other places of Manipur. Further, looting of arms happened from 9th IRB Khuman Lampak, 7MR Khabelsol, 3rd IRB Thoubal, MPTC Pangel, Churachandpur PS, Kangpokpi PS, Tengnoupal PS, Molrang PS, Kumbi PS, etc., Reports of burning of Churches and Temples happened at Koubru Leikal, Ekou Bazaar of Kangpokpi, Kondong Lalrembi of Moreh, Palte Veng of Imphal West and other places of Manipur. There has also been reports of firing and involvement of armed militant groups in these clashes at different places.

Till date in connection with these incidents, it has been learnt that many numbers of FIRs have been registered in various police stations of Manipur, many numbers of people have been displaced, and many numbers of people have been reported death due to the clashes. This riot is suspected to be a pre-planned conspiracy of both the communities (Meiteis/Meetels and Kukis) and suspected involvement of armed militants who are under SoO (Suspension of Operations) agreement with the Government, suspected involvement of drug mafia and illegal immigrants from Myanmar.

A thorough investigation is highly required of this widespread riot.

Hence, a regular suo-motu case under FIR No. 2(05)2023 CB-PS u/s 120-B/143/147/148/302/392/435/436/447/448/449/34 IPC, 25 Arms Act, 1959, 16 UA(P) Act 1967 has been registered against unknown persons for investigation.
