



Sir,


This is to inform you that on the 28th of May 2023, around 11 AM, a Meitei mob numbering over 500 people, consisting of members of the Arambai Tenggol wearing their trademark black T-shirts, along with state police commandos attacked my village. They were armed with sophisticated automatic rifles and shot indiscriminately with an intent to kill.

We were forced to flee our village. My 3- room house was burnt down and 20 bags of paddy and cash worth Rs. 20,000 (twenty thousand only) was looted.

I therefore humbly request your good office to kindly take necessary action in this regard.
