



This is to inform you that on the 28<sup>th</sup> of May 2023, around 11 AM, a Meitei mob numbering over 500 people, consisting of members of the Arambai Tenggol wearing their trademark black T-shirts, along with state police commandos attacked my village. They were armed with sophisticated automatic rifles and shot indiscriminately with an intent to kill.

We were forced to flee our village. My house was burnt down including all my possessions inside.

I therefore humbly request your good office to kindly take necessary action in this regard.


