Sub :- Filing of FIR against Armed Rioters

Sir.

- 1. Pursuant to the requisition by state govt for maintenance of Law and Order, protection of civilians and area domination, internal security columns of Assam Rifles were deployed in terms of the said requisitions. On the morning of 29 June 23, Assam Rifles columns deployed on duty at L Munlai village and National Sport University heard sound of firing from the general area of Haraothel at 0530hrs. It was learned that armed rioters who came from the valley side had attacked Haraothel village with fire arms and a firefight had started between the armed rioters and stated armed volunteers of the village defense committee. There was heavy exchange of fire between both the parties till 0900hrs and subsequently intermittent fire continued till 1200 hrs. After the fire subsided, AR columns along with police rep from Leimakhong PS (HC Dimngel Lenglam and HC James Khongsai) carried out search of the affected area to look for injured civilians for evacuation as well as for ruling out further presence of armed rioters and weapons. During the search, body of an unidentified armed rioter was found in general area of Haraothel along with one INSAS rifle (Regn No 18245440), one magazine and one live round. Later the deceased was identified as W Nilkamal Singh, s/o W Iboyima Singh, r/o KhaidamLaikai, Porompat Sub-division, Imphal East.
- 2. The recovered body was handed over to PS Lamsang on 29 Jun 23 at approx 1710hr in coordination with SP, Imphal West, by AR column. The recovered weapon, magazine and live round is being handed over along with this letter. You are requested to kindly file an FIR against the unknown armed rioters and investigate the incident of rioting with deadly weapons, attempt to murder with firearms, causing hurt with dangerous weapons and unlawful carriage of dangerous weapons and usage of said fire arms and ammunition to include automatic weapons.
