With due respect, I have the honour to state that on 29<sup>th</sup> June, 2023, as instructed by Superior Officer's HC Dimngel Lenglam and HC Th. James Khongsai of LMK-PS were deployed to collect the deceased details who has been killed in firing exchange between Army personal and some unknown armed miscreant from Meitei community at L. Tangnaum (Haraothel Hill range) (This Refers to GD. No. 05/LMK-PS/2023, Dated 29/06/2023).

Unfortunately, while performing their assigned official duties, one HC Dimngel Lenglam of LMK-PS S/O Lunlam Dimngel R/O Ichaigojang Village, Saikul Sub-Division, Kangpokpi District was shot on his neck by some unknown armed miscreants suspected to be from Meitei community at around 5:19 PM. As a result of which, he succumbed to his injury at the spot.

Therefore, I request you to take up necessary legal action according to the Law.
