



Sub :- Filing of FIR against Armed Rioters

Sir,

1. Internal Security Duty columns of Assam Rifles were deployed in the general area of Haraothel for protection of civilians and maintaining peace in terms of the requisition by the Govt of Manipur. On 29 June 23 said columns were deployed on duty at National Sports University(NSU), Haraothel and at L Munlai village along with police rep from Leimakhong PS (HC Dimngel Lenglam and HC James Khongsai). At 0530hrs on the morning of 29 June 23, armed rioters attacked the village of Munlai and also the AR columns on duty deployed in the vicinity of L Munlai and NSU, Haraothel. On being fired upon by the armed rioters and under threat to own life and that of civilians in the area, Assam Rifles troops responded in a calibrated manner with controlled fire, in self-defense and for protection of civilians in the area.
2. The sustained deadly fire by the armed rioters with automatic weapons upon the security forces was in a trained and planned manner. The said fire continued till 0900hrs and thereafter intermittently/sporadically till 2000hrs. After cessation of the firing, search of the affected area was carried out for evacuation of injured and ruling out presence of rioters/ arms ammunition etc. During the said search, following weapons and ammunition were found Local made Lathode/RL -1, Mortar (2 inch) – 3 rds, 7.62 MMG – 1 rd, AK – 10 rds, 7.62 x 51mm LMG – 8 rds along with fired cases of .303 – 36 cases, INSAS – 5 cases, 7.62 MMG – 7 cases. No casualty of civilians was reported to the Assam Rifles column.
3. You are requested to kindly file an FIR against unknown armed rioters and investigate the incident for attempt to murder with deadly weapons, to deter public servants suppressing riots, causing hurt with dangerous weapons and unlawful carriage of dangerous weapons and unauthorized usage of fire arms and ammunition to include automatic weapons.
