This is to inform you that on the 4th of May 2023, around 9 AM, a Meitei mob numbering over a hundred (100) attacked my village. The mob consisted of members of neighbouring Meitei villages on the frontline, who were backed up by members of the Arambai Tenggol wearing their trademark black T-shirts along with members of the state police commandos bringing up the rear. They were armed with sophisticated automatic weapons and shot indiscriminately with an intent to kill.

We were forced to flee our village, leaving behind our house and all our possessions.

I therefore humbly request your good office to kindly take necessary action in this regard.
